With due respect, I have the honor to state that I am the resident of Khumujamba Meitei Leikai, Churachandpur District. P.O/P.S: Churachandpur - 795128, Manipur.

That on 4th May 2023 at around 12pm, some unknown miscreants belonging to Kuki Community burnt down my house with criminal intention to cause damage of property and life with deadly weapons including automatic rifles, knives etc.

As a results many houses and properties worth crores were destroyed and burnt to ashes. Among which my house under New Patta No. 813/2383, of 96 – Khoipibung Lourup, covered by Dag No. 1383/1537 measuring an area of 0.5 acre of Ingkhol of class permanent resident was also destroyed by the mob. Many properties were burnt and leftovers were looted.

Lists of properties (both immovable and movable looted, burnt and destroyed are given below)

- 1. Cash 6 Lakhs
- 2. One storey pucca building house with 6 rooms
- 3. One grocery shops worth 3 lakhs goods and items
- 4. Furniture includes 3 wooden beds, two VIP sofa sets, two iron dressing table, 1 TV with stands, 1 dining sets, 3 iron almirah, 2 study table, 2 wooden almirah, one kitchen shawbox with utensils worth around 60 thousands
- 5. Gold and Jewellery includes 3 gold chains, 10 rings, 4 gold earings, 2 bracelets
- Vehicles includes one 2-wheeler (Mestro edges g-grey) R/R MN 06 SG 5864
- 7. Documents All educational certificate of applicants.
- Electronic items 1 iron, 1 washing machine, 2 oven, IRO, 1 laptop, 1 iron and steel works machines, 1 fridges
- 9. One bore well worth 2 lakhs.

The approximate total loss of properties would be Rs.3 Crores.

It is therefore kindly requested to take necessary legal action on those culprits who were involved in the incident. I hereby lodges my complaint at Lamphel Police Station as I had fled from my RUNIARI OF OF FIR NO.1448 (08) 2023 CUP-NS US 147/148/149/457/ residence for the safety reasons.
