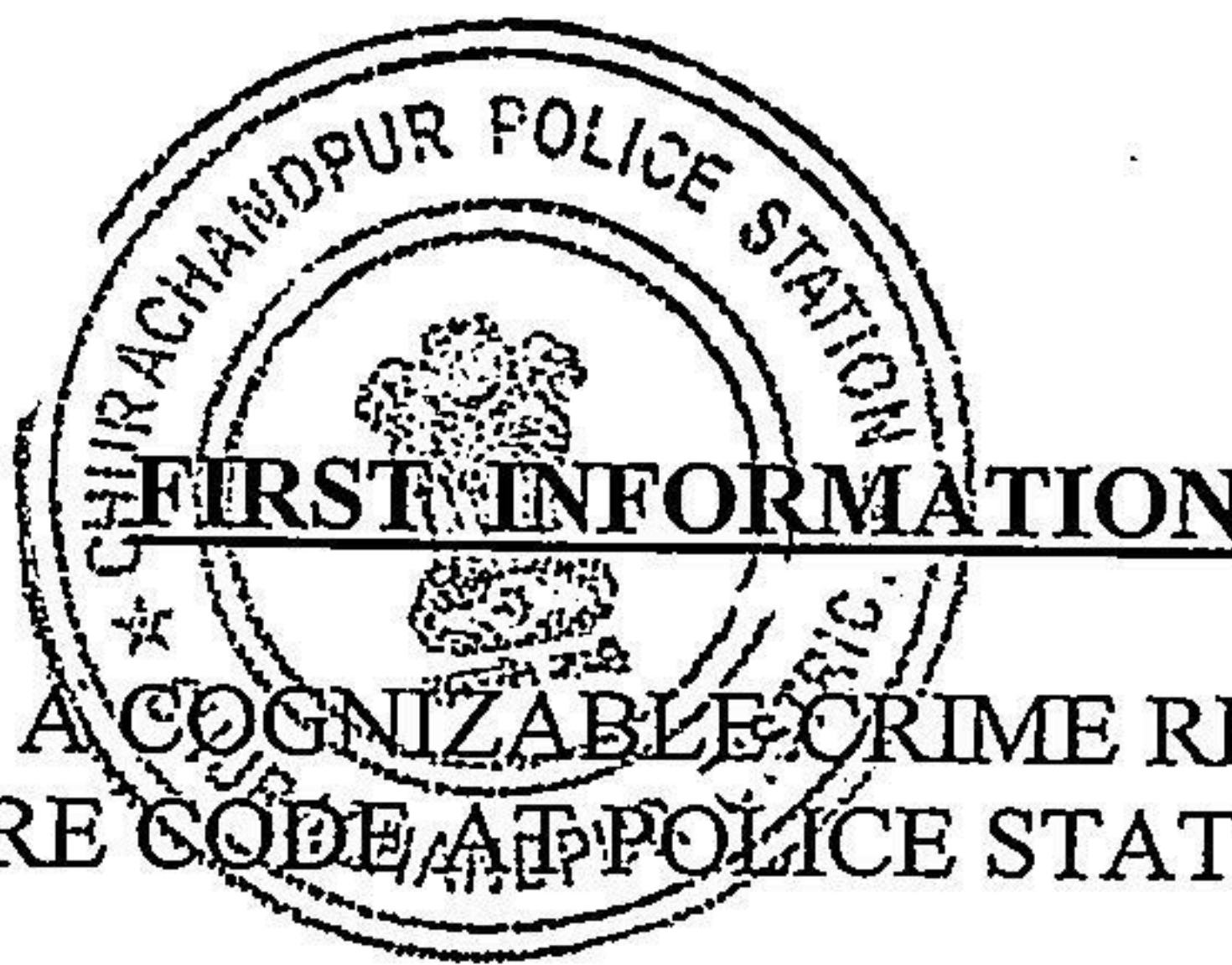

Sir,

I am to state that on 4th May 2023 at about 11.00 A.M. our locality, Khumijamba Meitei Leikai, New Bazar, Churachandpur P.S. was under mob attack by thousands of unknown miscreants belonging to Kuki community with criminal intention to cause damage of property and life. They were armed with deadly weapons including automatic Rifles, DSBG/CSBG Guns, knives etc with intention of murder.

As a result, many houses and properties worth Crores were destroyed and burnt to ashes. Among which my houses located at Khumijamba Leikai
