With due respect I would like to state that our Eastern Motors showroom (Maruti Suzuki) located at Churachandpur, which is under lease agreement with the land owner Mr. Benjamin Hmar was vandalized by a group of unknown people numbering around 100 and broke the furnitures, computer, printer, UPS and other glasses at the showroom on 6<sup>th</sup> May 2023 at around 1 am (midnight) as per information from the land owner Mr. Benjamin Hmar.

In addition to the destruction of the above items also informed us that, the mob also took away two Maruti Suzuki vehicles which were put on display at the showroom and 4 nos. of HERO two wheelers which were kept for promotional purpose.
