We were rescued by Armed Security Personal and provided shelter at a safe place in
hurachandpur for the first few days.
Later on, we have been evacuated to Relief Camp within Bishnupur District under armed
scort. Hence, I was not able to report regarding this matter to the police on time. We are still in
ne Relief camp at the time of filing this application.
In the above facts and circumstances, it is therefore respectfully requested that your
oudself may cause the arrest of the miscreants who belongs to the Kuki community involved in
e burning/dismantling/ damaging my properties and injuring and take up
FIR against them as soon as possible for the interest of justice.
