Sir,

I have the honour to report that my JCB Excavator 3DX Super 4WD bearing Regn. No. AR02A-0332 having Engine No. H00173661 & Chassis No. HAR3DXSUJ02711979 is used under Work Order for Package No. 3255/PMGSY(B-I, 2018-2019) for the construction of Road from L031-Tulaphai to Bangkot under Henglep Block of Churachandpur District, Manipur. Due to sudden outbreak of the crisis that broke out on 03/05/2023 which leads to ethnic violence and mass destruction of properties throughout the state, my vehicle remained stranded at the said location i.e. Tulaphai to Bangkot under Henglep Block of Churachandpur District and could not be brought to safe area and left behind at the work site of their Project. Later, I received information from the reliable resources that the vehicle which was stranded at work site was found stolen/lost on 15th May, 2023. The cost of the missing vehicle is Rs. 25,00,000/- (twenty five lakhs).

Considering the above facts, I request you to kindly take appropriate necessary legal action as per law.
