Sir,

I the undersigned, have the honour to state that on 04/05/2023 at 10:15 am I along with my friends have left our work place i.e, Khanpi Village and Ainoyang Village under Hinglep-PS jurisdiction, Churachandpur District, Manipur due to the Communal riot started from 03/05/2023 between Meitei and Kuki to save our life. We abandoned (2) Nos. SHAKTIMAN bearing Reg.No. MNO5C 2797, Chassis No. 88VFJ52068P and Engine No. B55771SVF & SHAKTIMAN bearing LOT No. 520, Chassis No. 97VFJ74799P and Engine No. B37695SVF at Khanpi Village which is used for commercial purposes. Later, a reliable information was found on 14/08/2023 at 7:45 pm that, the said Vehicles were looted by unknown Kuki armed Militants and Kuki miscreants. The approximate Value of 1 (One) Vehiles is @ Rs. 7,00,000/- (Seven Lakhs). Total cost of the lost 2 Vehicles is @ Rs. 14,00,000/- (Fourteen Lakhs).

So, I therefore request you to kindly take up legal necessary actions against the above mentioned unknown accuseds.
