I the undersigned have the honour to report that on 04/05/2023 at @ 1:00 pm, I along with my vehicle driver have left our work place i.e. Phaibung Village Under Henglep PS, Churachandpur District, Manipur due to communal riot started from 03/05/2023 between Meitei and Kuki to save our life keeping my Shaktiman bearing begistration no. MN04A/0440, Chassis No. 96VF771015P & Engine No. CXM053247 which is in the name of Khangembam Indramani Singh S/O Kh. Yumjao Singh of Thoubal Athokpam at our work site Phaibung Village. On 08/09/2023 at @ 4:30 pm received an information that the said Shaktiman was looted by armed persons suspected to be Kuki militants/miscreants from Phaibung Village Under Henglep Police Station, Churachandpur District, Manipur. The approximate value of my Shaktiman is Rs. 4,70,000/-(Rupees four lakhs and seventy thousand).

I could not report to the police station in time due to present unrest law and order situation.

So, I therefore requested to kindly take up necessary legal action against the unknown culprits.
