Subject : Complaint against desecration of Ibudhou Thangjing Khuvamlen at
Thangjing Chingsang.

Sir,

I, the undersigned in representation 'Committee On Protection & Preservation of the
Historical Rights of Koubru & Thangjing Hill Ranges' (CPPKT) have to submit this complaint for
necessary action.

That, on the 11th of September, 2023, at around 3 p.m. to 4 p.m., footages of the
Ibudhou Thangjing Khuvamlen at Thangjing Chingsang having been desecrated by plantation of
Chrstian-Cross and flag of ZRA as well as another unknown flag, at the khuvamlen, by suspected
kuki-zo militants/miscreants, has been widely circulated in the Social Media. Ibudhou Thangjing
Khuvamlen is one of the most Sacred Shrines of Meetei-Hindus that is associated with the
Meetei folklore of Creation of the earth and procreation of human beings. Desecration of this
important Meetei-Hindu shrine is an internationally cognisable religious offence, a violation of
human rights, and challenge to the whole Meetei-Hindu community. It may be recalled that Kuki
Student's Organisation, Henglep had restricted entry of anybody to Thangjing Chingsang without
prior permission from them on the 5th of May, 2022, and in retaliation, 'Committee on Protection
& Preservation of the Historical Rights of Koubru & Thangjing Hill Ranges' had imposed a counter
restriction to the kukis of Henglep A/C on the 15th of May, 2022 following a public meeting and
resolution. On the 23rd May, 2022, under instructions from the Hon'ble Chief Manipur a joint
meeting of the KSO and the CPPKT was initiated by the then DGP Manipur at his Office chambers

and both parties agreed to withdraw all restrictions on both sides and signed a memorandum in this regard.

That, the said sacred site of Ibudhou Thangjing is a protected site under Section-4 of the Manipur Ancient and Historical Monuments and Archeological Sites & Remains Act, 1976 for an area of 4 Hectares (approx) located at Thangjing Hill range, vide Manipur Gazette Notification No. 376 date 14th November, 2022 and order dated 26th October, 2022 issued by the Commissioner (Arts & Culture), Govt, of Manipur.

It is therefore to report to book and mete out suitable punishment to the perpetrators and take up solid steps for protection of the shrine, otherwise the public will be left with no alternative but to take up steps to protect the shrine by ourselves.

ORDERS BY THE GOVERNOR: MANIPUR

Imphal, the 26th October, 2022

No.5/11/2008-S(AC): Whereas, vide this Government Department Notification of even number dated 26th November 2020, it was notified that the State Government contemplates declaring the Sacred Site of Ibudhou Thangjing (approx. 4 hectare) located at Thangjing Hills range and Sacred Site of Lord Koubru (approx. 2 hectares) and Lai Pukhri (approx. 4 hectares) located at Koubru Hill range as protected sites under Section 4 of the Manipur Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1976 and sought objections, if any, within period of 2 months and whereas objections were considered and have been set aside ,

Whereas "No Objection" has been received from Forest Department, Government of Manipur vide their letter No.3/14/2021/Forests dated 23rd June, 2022 with the following conditions;-

- i) Manipur Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1976 does not have overriding effect on Forest (Conservation) Act, 1980.
- ii) Necessary permission of Govt. of India under the provisions of FC Act, 1980 will be sought by the State Government as and when any non-forestry activity is proposed in these sites.
- iii) There is no restriction for management and protection of forest land by State Forest Department as per working plan prescriptions, after declaration of the identified forest land as protected Historical sites
- iv) There will be no change in management structure of the Identified forest land.
- v) Legal status of the forest land will remain the same.
- vi) There is no change in land use.
- vii) There is no breaking up of or clearing any forest land or portion thereof for any non- forestry purpose.

Whereas, the matter was placed before Cabinet on 13.10.2022 and Cabinet has approved the proposal for declaration of Sacred Site of Ibudhou Thangjing at Thangjing Hills Range and Sacred Site of Lord Koubru and Lai Pukhri at Koubru Hills Range under Manipur Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1976.

Now, therefore, the Governor of Manipur is pleased to declare the Sacred Site of Ibudhou Thangjing (approx. 4 hectare) located at Thangjing Hills Range and Sacred Site of Lord Koubru (approx. 2 hectares) and Lai Pukhri (approx. 4 hectares) at Koubru Hills Range, the details of which are given in the attached Schedule as protected sites under Sub-Section 3 of Section 4 of the Manipur Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1976 in the interest of the public.

Further the Department at all times shall comply with the conditions of the No Objection Certificate (NOC) No.3/14/2021/Forests dated 23rd June, 2022 stated above issued by Principal Chief Conservator of Forests & HoFF, Manipur.
