Today i.e. 7/10/2023 at 9:00 a.m, received a letter dated 15/09/2023 of Joint Students' Body Lamka, addressed to SP-CCP, with the subject- Request to cease and desist any activity on Thangjing Hill, in which the student body declaring that "Our people themselves have erected our religious symbol (Cross) and hoisted our cultural flag on the hill". They further stated that these symbols of love, unity, kindness and patriotism for the whole nation.

The letter then directed the SP to recall the instructions that were given to his subordinates to remove these things from the hill. Warning and threatening that failure to comply with this will be considered an attack on their rights, identity and survival. That, they will not take responsibility if there is untoward incident and the responsibility will be his (SP).

As the letter reveals the commission of acts likely to promote enmity between different groups on ground of religion, race and prejudicial to maintenance of harmony, and threatening the SP, it is considered to register a Suo-motu case under FIR No. 29(10)2023 U/S 153-A/506/34 IPC, against the two Joint Students' Body leaders and other unknown accused persons for investigation.
