I beg to state for your kind consideration and necessary action that on 3/5/2023 at around 7:30pm while I was at my house which is located at Tuilaphai, Sagol khunou village, Lepsa district, Manipur. A large number of armed and unarmed Kuki militant stormed my house and burnt my whole properties including house into ashes. The approximate value of the said properties burnt is Rs 21,00,000/- (Twenty one lakhs only).

So, I therefore kindly request your good self to initiate appropriate step for finding armed and unarmed kuki militant apprehend them and punished them in accordance with law.

Delaying of my report is due to uncertainty of relief camp and my personal health problem.
