Sir,

With due respect, I, the undersigned would like to lay the following few lines for your kind consideration and necessary action.

That, I am working as a Sub-Contractor by profession under the M/S Khetrimayum, First Class Contractor. As per approval of work order, Health and Family Welfare, Govt. of Manipur vide order No. 5/EE/Engg. Cell(Valley-I)H&FW/W-Order/2022-23/32 dated the 18<sup>th</sup> August, 2022, I have started work construction of PHSC Thingque, Churachandpur District, Manipur from the month April, 2023.

That, my work construction could not continue due to the ethnic clashes between Meiteis and Kukis that broke out since the beginning of the 3<sup>rd</sup> May, 2023. Due to fear and panic, all the laborers were compelled to abandoned and I am also could not visit my worksite again as it lies in a Kuki dominated area. On 20/10/2023 at 10:30 am, I was informed through mobile phone by one Mr. Pu Luaikhomang (L.K.) who is working as an Assist. Secretary, Thingque Village Authority, Henglep Sub-Division, Churachandpur that all the construction materials and tools have been stolen/looted by some unknown miscreants suspected to be Kuki militants in between the month of May to June, 2023. The approximate value of looted/stolen properties is Rs. 9,58,657/- (rupees nine lakhs and fifty eight thousands, six hundred and fifty seven) only (list of loss items is enclosed as Annexure-A). I could not report well in time due to lack of legal knowledge.

It is, therefore, requested you to kindly take up necessary legal action against the unknown miscreants at the earliest.
