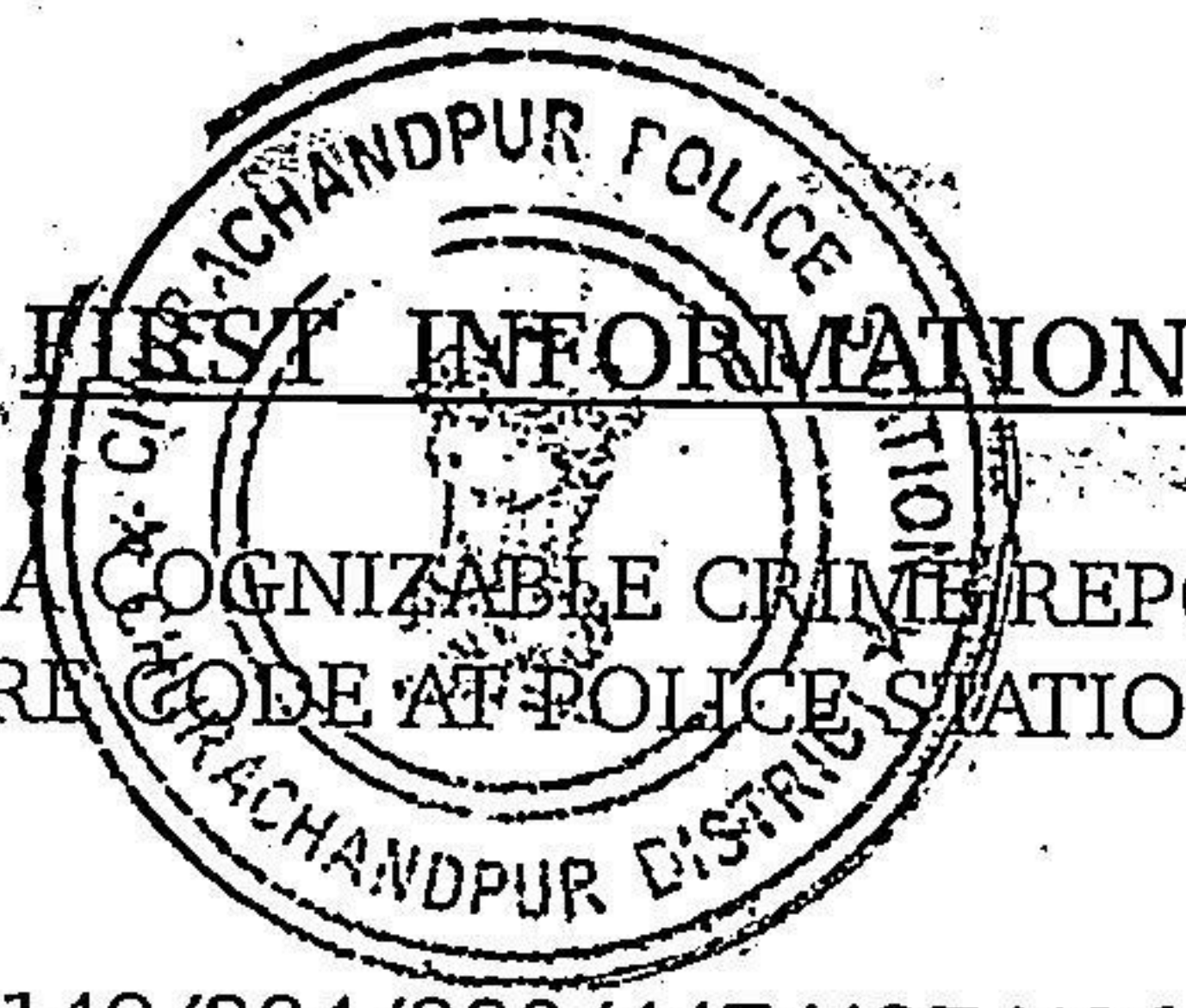

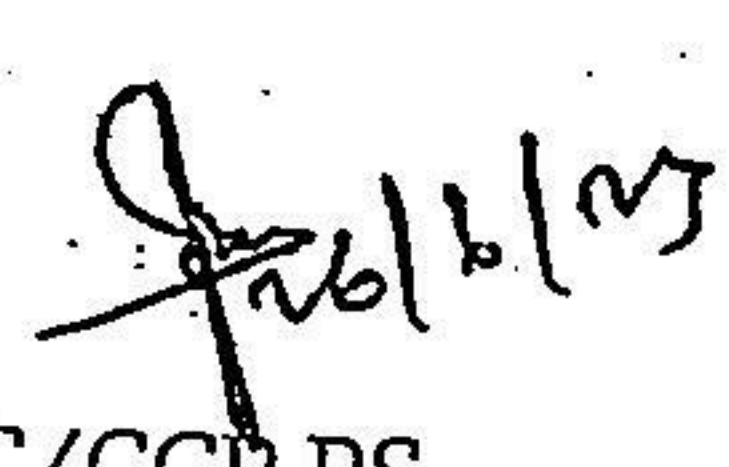

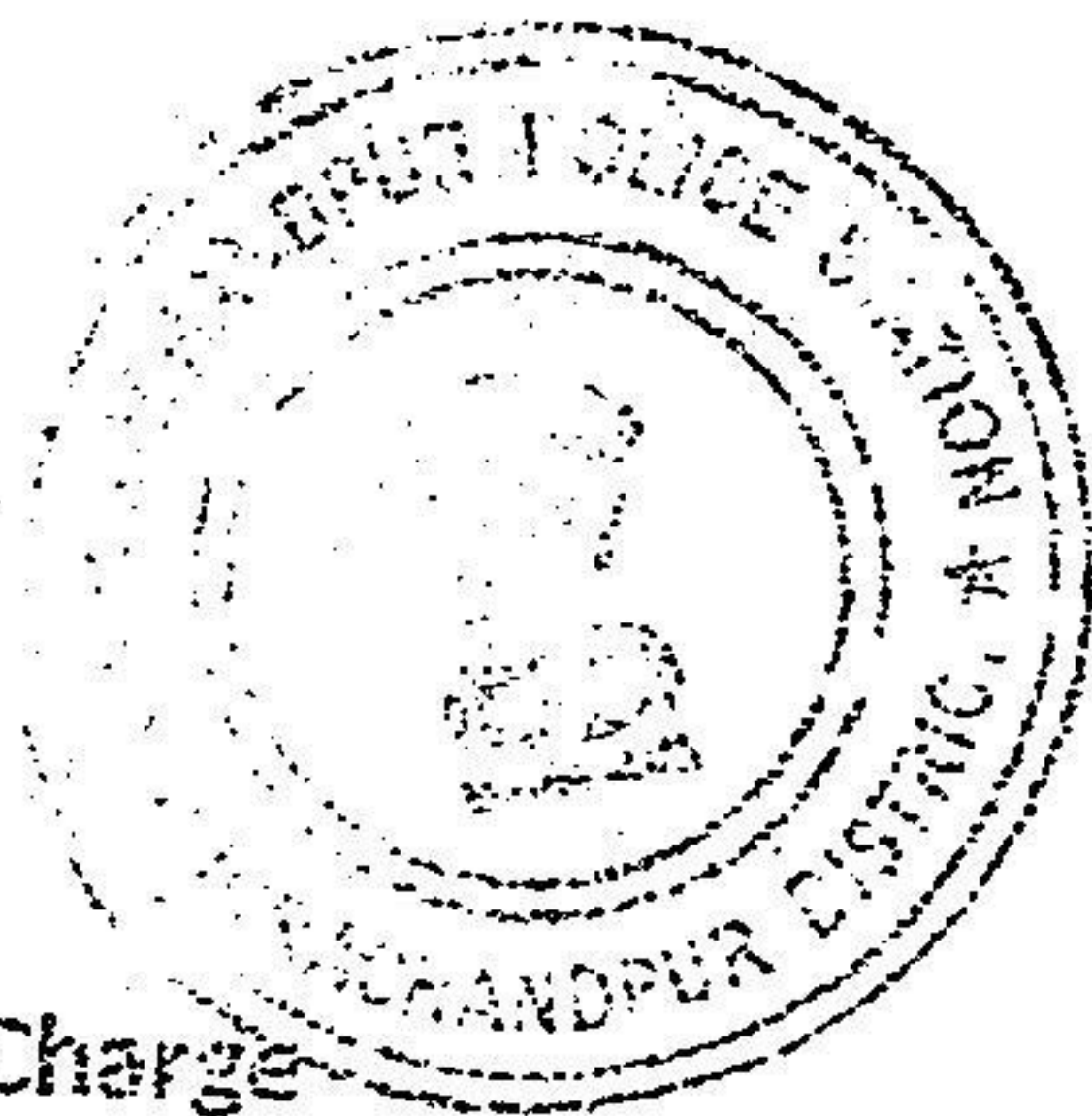

With due respect, I, the undersigned namely R. K. Ranjit
Age about 47 years, resident of old Bazar, Zinhang Lamka CEPUR
Beg to submit the following few lines for your kind consideration and necessary action.

That on 03-05-2023 at about 7.00 PM, some unknown persons numbering about 100 belonging to Kuki community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belonging and jeweleries were also burned/destroyed/stolen before burning/damage.

~~In the said incident~~ ~~was badly injured~~
~~due to pelting of stone/hacking with knife, shot from firearms toward us by the miscreants.~~

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belong to the Kuki community involved in the burning/dismantling/damage my properties and ~~injury~~ and take up an FIR against them as soon as possible for the interest of justice.
