

With due respect, I, the undersigned namely KIYAM KAMALA DEVI
aged about 44 years, resident of Khuga Tumpak
but now displaced and staying at the Relief Camp at Moirang Sandra Road,
Bishnupur District, beg to submit the following few lines for your kind consideration and necessary
action.

That on 03/05/2023, at about 7:30 pm, some unknown persons numbering about
3000 belonging to kuki community and gun toting kuki whom I believe to be kuki militants who are
under suspension of operation with the Government started attacking the undersigned along with
family members. Thereafter, kuki people and kuki militants started destroying and burning the
house of the undersigned resulting in all properties of the undersigned were razed to the ground
and all the belongings and jewelries were also burned / destroyed / stolen before burning /
damage.

In the above facts and circumstances, it is therefore respectfully requested you to kindly
take up an FIR against them as soon as possible for the interest of justice and restore my
properties to me.
