With due respect, I the undersigned Kh. Bire Angem
 aged about 36 years resident of Zeuhang Lamka (Meitei Leikai)
 beg to submit the following few lines for your kind information and necessary action.

That on 3rd May/23 at about 11:00 PM some unknown persons numbering
 about 20-25 belonging to Kuki community started attacking the undersigned along with family
 members. Thereafter, the Kuki people started destroying and burning the house of the
 undersigned resulting in all the properties of the undersigned were razed to the ground and all the
 belongings and jewels were also burned, destroyed. I sustained some burning damage.

In the said incident I was badly injured due to pelting of
 stones/rocking with knife/shot from firearms towards me by the rioters.

A separate sheet showing the particulars of the damage sustained by me is attached along
 with the present application.

In the above facts and circumstances, I therefore respectfully requested that your
 good self may cause the arrest of the miscreants of the Kuki community involved in
 the burning/dismantling/damaging my properties and injuring myself and take up
 an FIR against them as soon as possible for maintenance of law and order.
