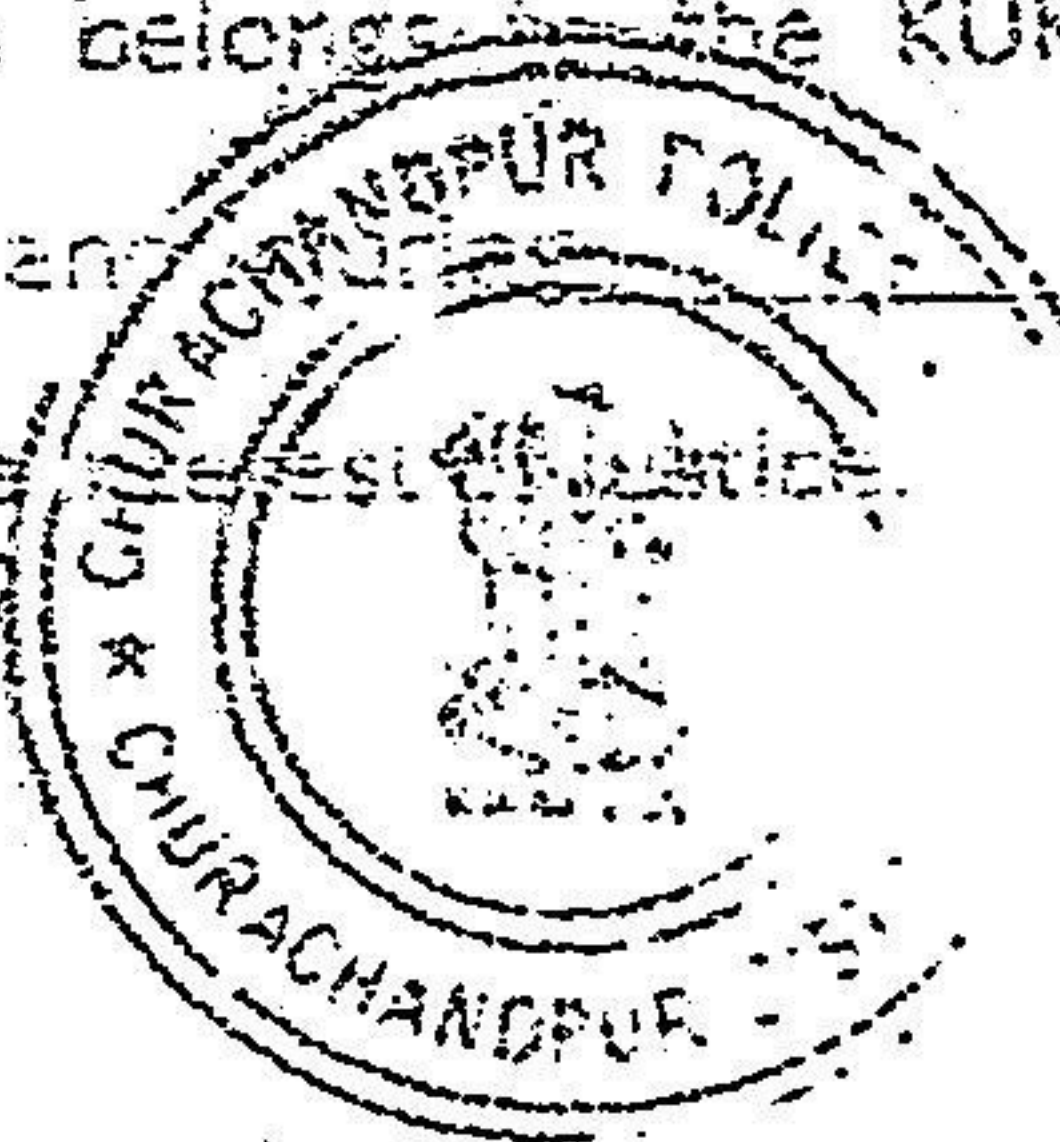
MEITEI LEIKAI CCPU beg to submit the following few lines
