With due respect, I, the undersigned namely <u>Nongmal-hem Sanahanbi</u> w/o(L) N. I keyama aged about 55. years, resident of <u>D. Dhailten ChuraChandpur</u>

beg to submit the following few lines for your consideration and necessary action.

That on <u>May</u> at about <u>G. 00 pm</u>, some unknown persons numbering about

1000 belonging to Kuki and Kuki community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings items were stolen before burning/damages.

In the said incident, was badly injured due to pelting of stones/hacking with knife/shot from the firearms towards us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.
