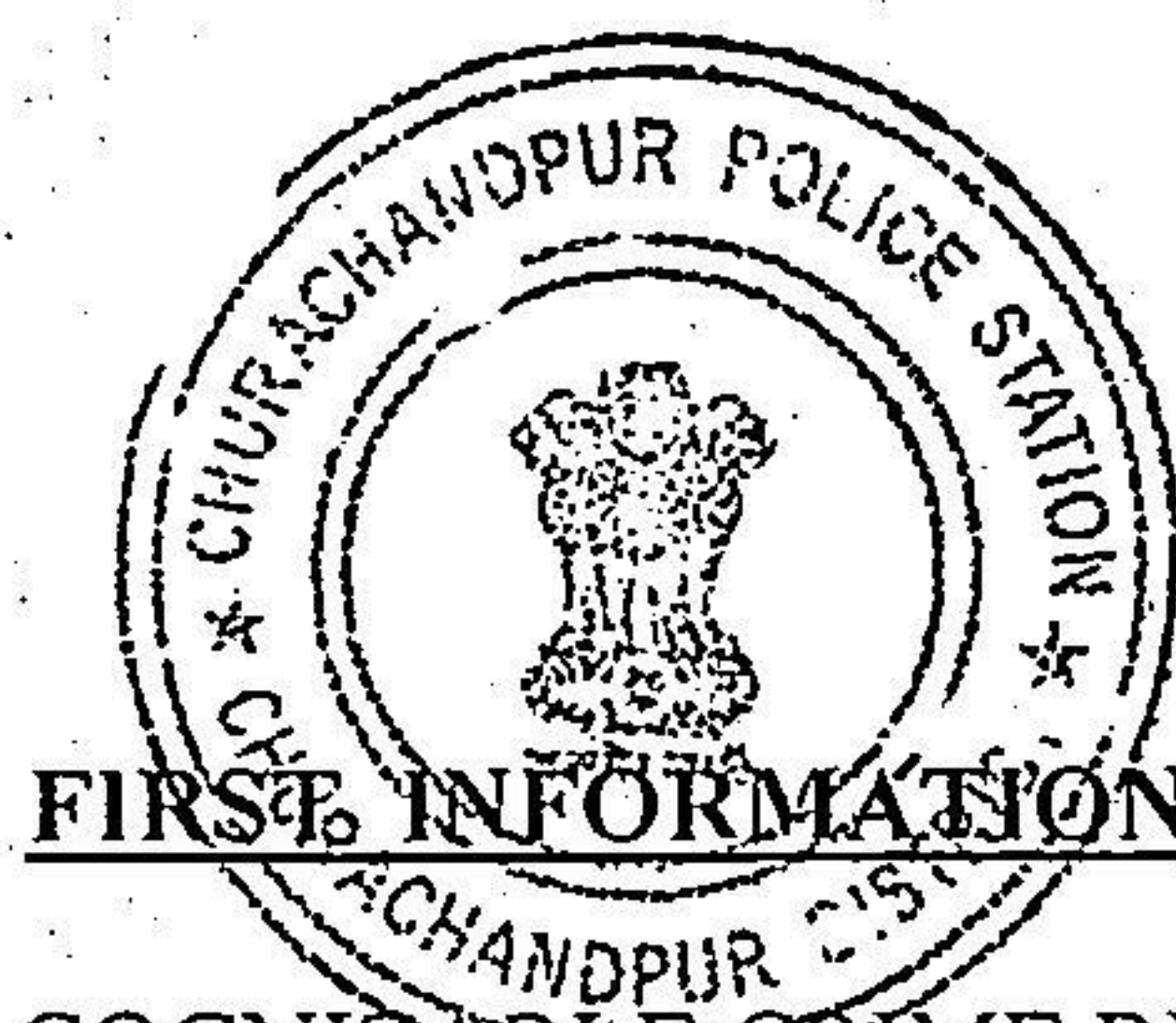

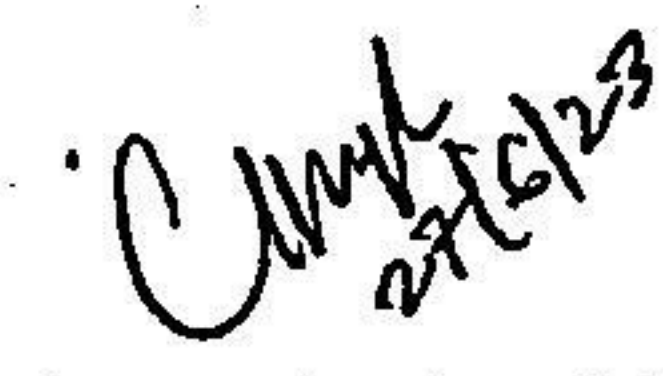

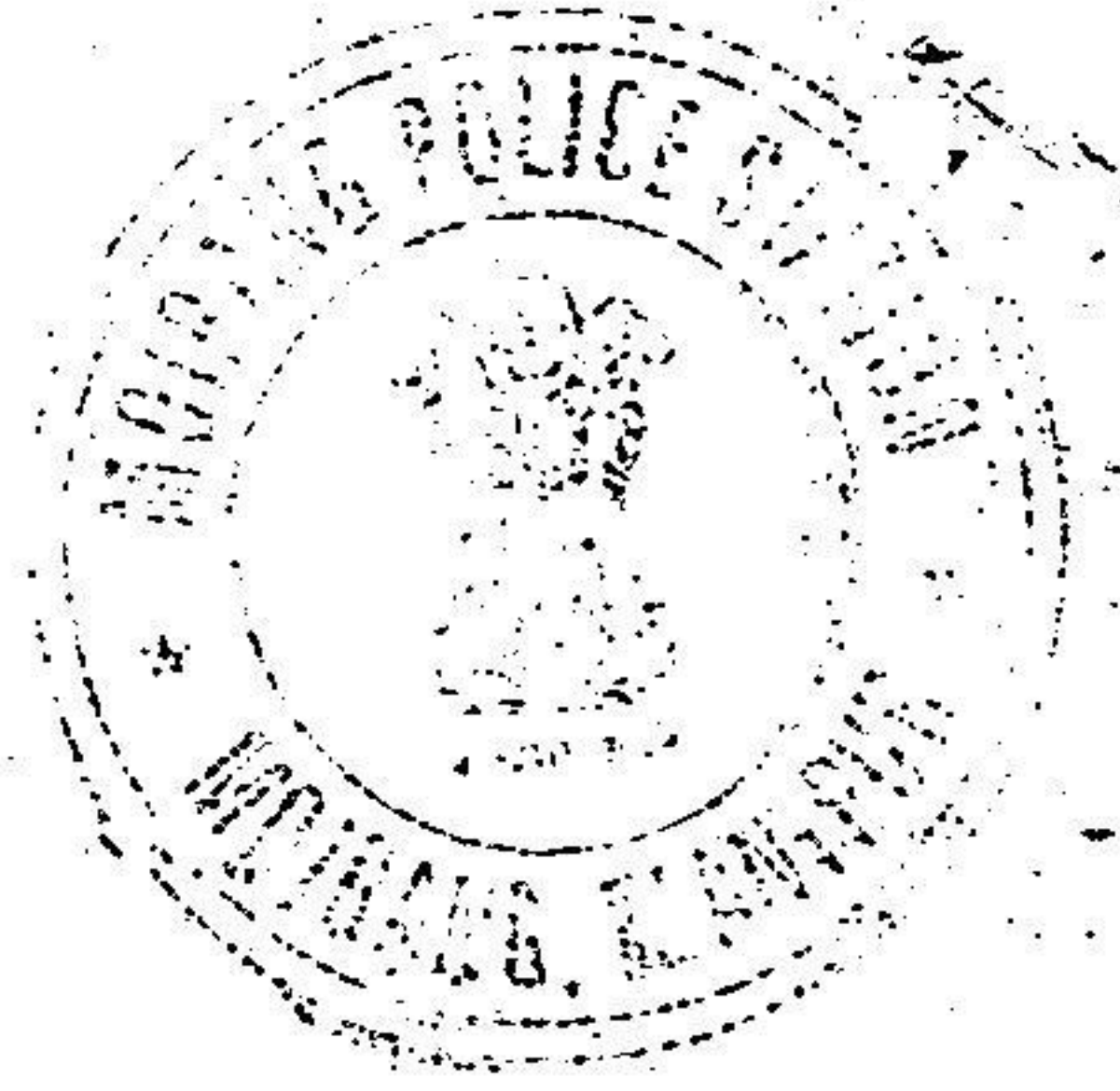

With due respect, I, the undersigned namely Adhikarimayum Chiranjiv Sharma aged about 43 years, resident of Saiton Awang Leikai, Bishnupur District beg to submit the following few lines for your kind consideration and necessary action for the reason mention below that my mobile and accessories shop name as "Sharma Mobi Café" located at Churachandpur Old Bazar had been looted/robbed/destroyed/burned including its furniture, CCTV camera and other properties of this shop, on and around 4th & 5th May, 2023 by some unknown Kuki community people, no fewer than 300 persons. Along with this a white Verna car Registration number ML-05K3985 have been burned down, at around 9 AM.

In the above facts and circumstances, I therefore requested you to kindly make a serious enquiry about this matter and help me in getting justice by filling an FIR against unknown Kuki people at the earliest possible.

Your quick action will be highly appreciated. For which acts of kindness I shall ever remain thankful to you forever.
