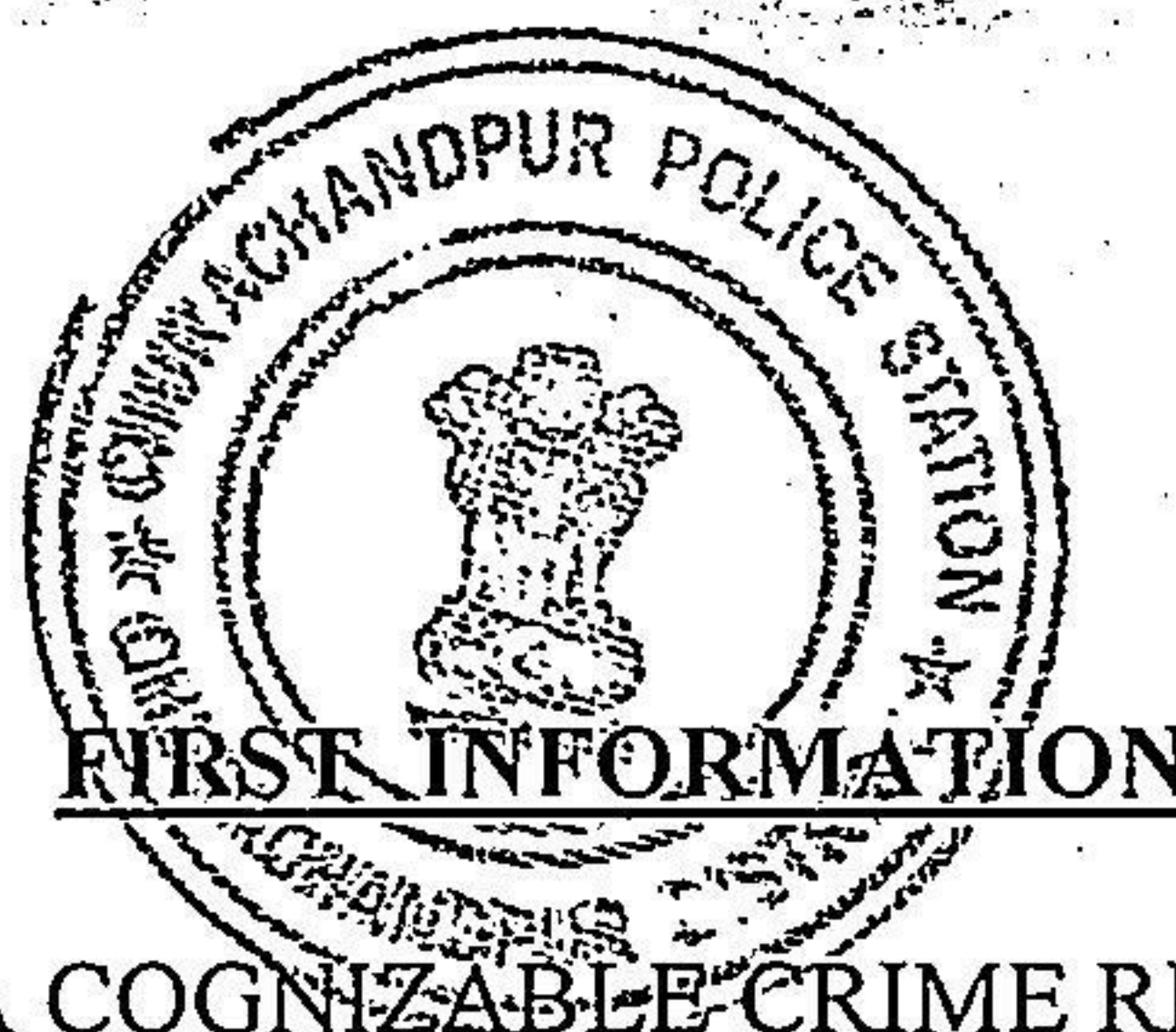

Sir,

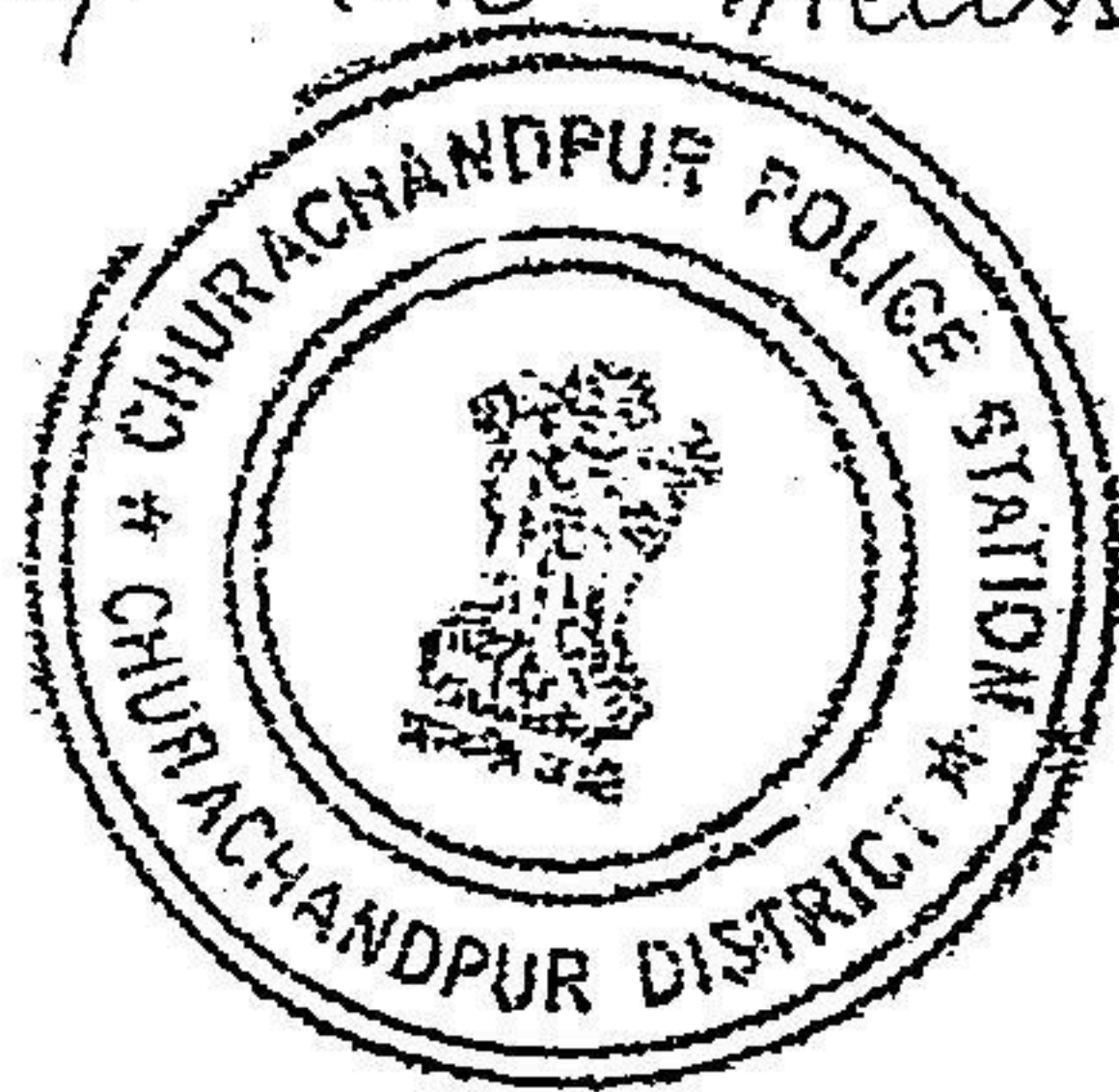
With all due respect, I would like to report you about
the recent violent incident taken place on 4th of May 2023
that our locality's Mandir was burned down and our locality's
Mandop was destroyed in a very brutal and heartless way.

The incident took place at around 6:00 Am in the morning
on 4th of May 2023, where approximately 40-50 Kuki suspected militants
rushed into our locality shouting slang words and hitting various
houses gates and electric post. After few minutes the Kuki suspected
militants started firing and destroyed various shops, houses and
the mandir along with the Mandop.

Various marks and paints were splashed and sprayed at the
door of the mandir showing disrespect and hatred towards
our religion and community.

Therefore, such act should be condemn and I urge the
concern department to take up the necessary action at the
earliest.
