

With due respect, I, the undersigned namely LOUR EMPAM MANGALMACH aged about S.S. Years, resident of KHUMUTAWMA MEITEL LEIKH beg to submit the following few lines for your kind consideration and necessary action.

That on Direction at about 100, some unknown persons numbering about 100 belonging to Kuki Community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleries were also burned/destroyed/stolen before burning/demolished.

In the said incident ....... was badly injured due to pelting of stones/hacking with knife/shot from firearms towards us by the miscreants.
