

Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleries were also burned/destroyed/stolen before burning/demolished.

In the said incident was badly injured due to pelting of stones/hacking with knife/shot from firearms towards us by the miscreants.
