Sir,

With due respect, I the undersigned have the honour to report that I am working under the PMGSY Project: Construction of road from Phaibung to Muntha under Henglep block of Churachandpur District PKG No. MN03213. But due to sudden outbreak of the crisis starting from 03/05/2023 and has been continued till now in our project area i.e. Phabung to Muntha of Henglep Sub-Division, Manipur which lead to mob violence and mass destruction of properties. Luckily our workers, drivers and official staff of our project were all running and shifted to safety area but we could not bring back our vehicles and heavy machineries to safe area and left behind at the work site of our project. Also, some of our machineries were hiring from different owners.

Unfortunately, we are unable to report earlier due to unstable law and orders of Manipur at that time, but we have received an information that truly state that our heavy machineries and vehicles which are left behind were lost and some of them were burned down to ashes by some unknown persons suspected to be Kuki miscreants including all the related documents of machineries between date 07/05/2023 and 20/05/2023. All the machineries lost or burn down are amounting to Rupees: 2,43,00,000 (Two Crore Forty-Three Lakhs Only).
