

Subject- request to register a complaint in c/w recent attack upon me and my villagers.

Sir,

With due respect, I am the chief of Gamnomphai village and would like to inform and register a cognizable offence carried out against me and my village in the intervening night of 3rd May, 2023 at around 7:00 Pm by Meitei community, who were armed with sophisticated automatic guns like AK's, Rifles, Pistol, Machette and Knife whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSOs.

Due to such attacked carried out against my village, being in vulnerable state. Me and my family along with villagers numbering male 16 and female- 20 had fled from our village fearing to lose our life.

As such, we have been taking shelter as refugee at the relief camp at Kingkin nearby Molcham, Churachandpur till date.

On inquiry, 5 (five) household were torched and burned. Domestic animals were killed and taken away, properties were looted and taken away rendering my village at helm.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my villagers for the end of justice.
