

**Subject :-** Report on criminal intimidation, vandalism, looting/ robbery and burning of properties that took place on 4<sup>th</sup> May, 2023 at about 01:00 AM at Seitol Khunou within Phongakchao Ikhai P.S.

Sir,

I, the undersigned, a victim presently taking relief / shelter at Mission Veng, Hiangtam Lamka have the honour to state the following for your kind intervention and favourable action that, on 4<sup>th</sup> May 2023 at about 1:00 AM, unknown Meitei goons armed with deadly sophisticated weapons came to our village wherein we all ran and hide in fear of our lives. As we ran and hide, the said Meitei goons entered our house and looted/ robbed all the valuable items and vandalized / burnt down all the remaining household/ domestic goods alongwith the shop attached to our house and also including our livestock and vegetable plantation.

- (1) Immovable property – Kutcha house and shop attached to it.
- (2) Moveable property – (i) All the domestic goods inside the house;  
(ii) Livestock - 30 nos of Chicken and 30 nos. of Duck

That, the estimated value of properties destroyed, looted and burnt is estimated to be worth approximately Rs. 7,00,000/- (Rupees Seven Lakh) only.

Being displaced, I am filing this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
