

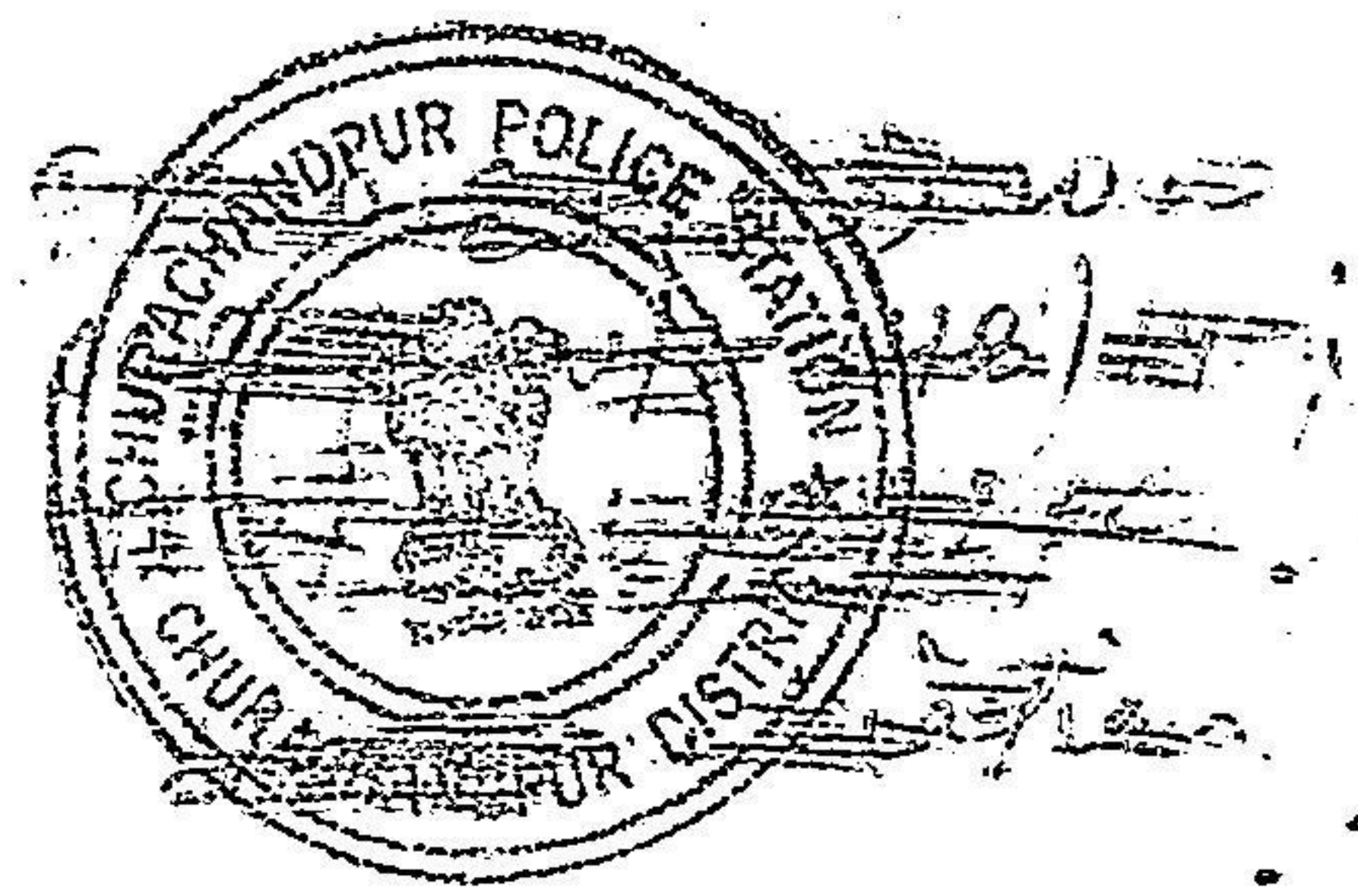

I, **Lunjapao Simte Chief** of P.Minjang, Samulamlam Block, Churachandpur, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my village was attacked by a group of Meitei Mobs and burn down all the valuable properties within the village with the total worth (approx.) Rs 57,00,000 (Fifty Seven Lakhs) only.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
