

Sir,

I, **Lhingkhokim** d/o (L) **Ngampao** of P.Minjang, Samulamlan Block, Churachandpur, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx.) **Rs 10,08,300 (Ten Lakhs Eight Thousands and Three Hundreds)** only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to safety in the same fateful day.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
