Subject:- Report on sustaining of bullet injury.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable – action praying for registering an FIR and investigate the matter by due process of law:

- 1. That, I Shri. Lallawmsang S/o Ginmuanthang, aged about 17 years, belonging to the Paite tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
- 2. That, at about 09:30 pm on the 3rd of May 2023, I was caught in an indiscriminate fire shot by meetei/meitei armed personnel suspected to be members of Meetei Leepun and Arambai Tengol at Thengra Leirak, Churachandpur District, during which I sustained a bullet injury on my chest, fortunately survive the ordeal, however due to undergoing medical treatment and ignorance of the relevance provision of law there has been delayed in filing a complaint of the incident.
- 3. That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by Arambai Tengol and Meetei Leepun aided state forces, I am filing this with a request to kindly take necessary legal action against the perpetrators as per law.
