

Subject:- Report on sustaining of bullet injury.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Shri. Lallawmsang S/o Ginmuanthang, aged about 17 years, belonging to the Paite tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
2. That, at about 09:30 pm on the 3<sup>rd</sup> of May 2023, I was caught in an indiscriminate fire shot by meitei/meitei armed personnel suspected to be members of Meetei Leepun and Arambai Tengol at Thengra Leirak, Churachandpur District, during which I sustained a bullet injury on my chest, fortunately survive the ordeal, however due to undergoing medical treatment and ignorance of the relevance provision of law there has been delayed in filing a complaint of the incident.
3. That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by Arambai Tengol and Meetei Leepun aided state forces, I am filing this with a request to kindly take necessary legal action against the perpetrators as per law.
