Sir,

I, John Simte s/o Suanjaneh Simte of P.Minjang, Samulamlan Block, Churachandpur, am bringing to your kind notice that on the 4th May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mob.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx.) Rs 10,69,600 (Ten Lakhs and Sixty Nine Thousands and Six Hundreds) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine Grace and fled to safety on the same fateful day.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.

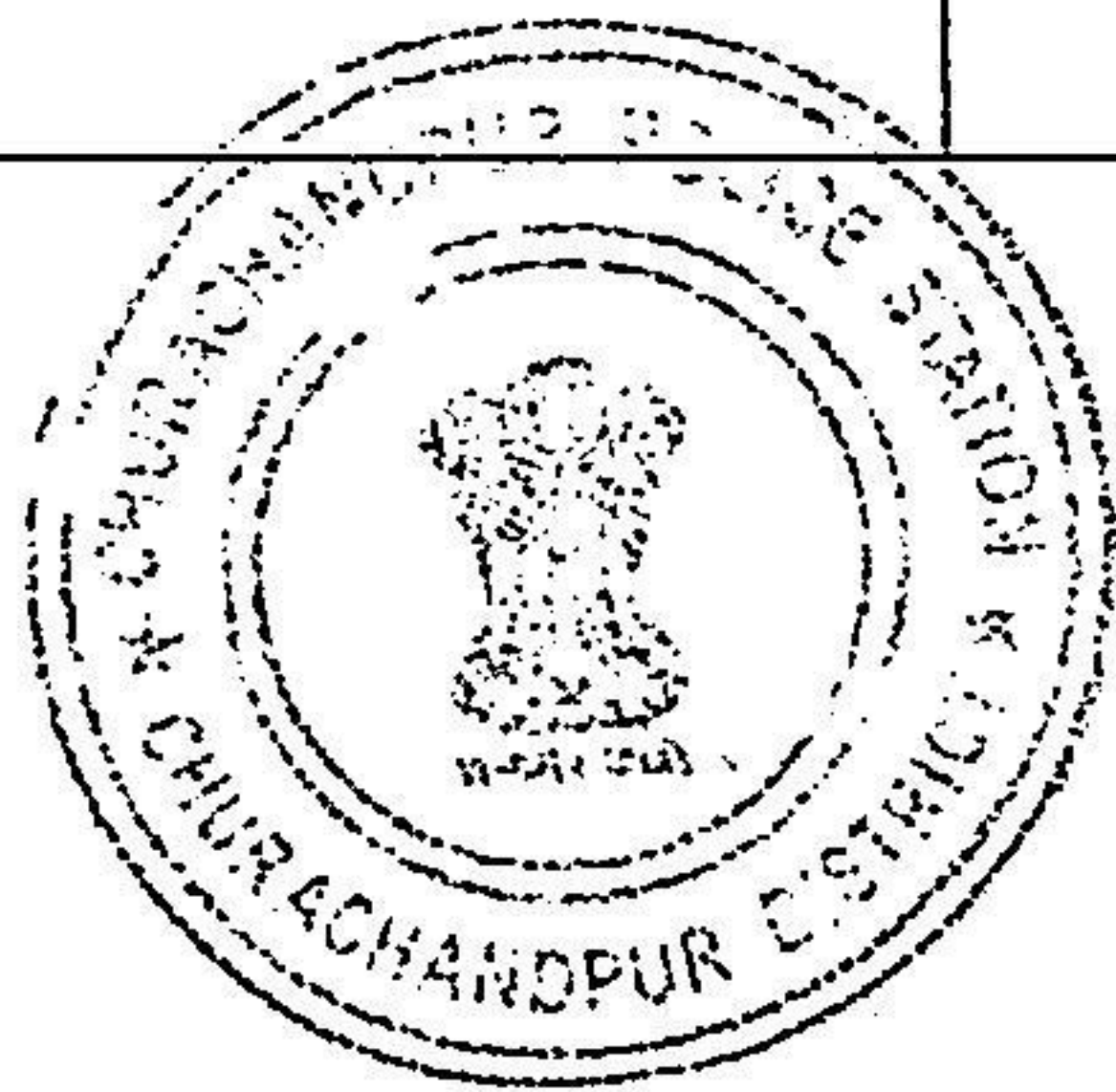
