



With due regard, I the undersigned have the honour to state few line for your kind consideration and needful action.

That, on 04/5/2023 at around 4.30 pm, while I was at the Inter Village road of Khongsai Veng, Sangaiprou for some personnel purposed. Suddenly, I was hit by a bullet at my abdomen which was shot/fired from the Khongsai Veng side by unknown miscreants belonging to Kuki Community in order to kill me. As a result of which I received severe injury at my abdomen and immediately evacuated to JNIMS medical treatment and later referred to Raj Medicity for further medical treatment. The cause of delaying my report is on engaging my family for my medical treatment.
