

3rd May 2023 at around 8:00 pm, our locality,
molbung melai police was under mob attacked by
thousands of Kuki community miscreants.


As a result, many houses and properties
were destroyed and burnt to ashes including my
house (permanent residence).

Property looted and destroyed includes:
immovable properties like houses, including movable
(approx 8 lakhs)

properties -

- a) Furniture: 3 almira^{worth} around 1 lakh, 2 godrej^{worth}
around 50 thousand, 3 beds^{worth} around 1.5 thousand
4 bench^{worth} around 20 thousand, 6 tables^{worth} around 40 thousand

b) Electronic items: TV worth 15 thousand, washing machine worth 10 thousand, refrigerator worth 15 thousand, 3 rice cookers worth 20 thousand, 1 laptop ^{worth} 50 thousand.

c) Kitchen items: 3 cylinders ^{worth} 10 thousand, 2 gas stove worth 8 thousand, utensils ^{worth} around 50 thousand, 1 kitchen almirah worth 20 thousand.

d) Cash for naryp worth 25 lakhs.

e) Household stuff including clothing and daily needs worth ₹ 1.5 lakhs.

f) 3 Hens, 7 ducks and 3 cats worth ₹ 15 thousand.

Total loss of properties at my residence would be about 25 lakhs. (approximately)

I is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complaint at Dampal Police Station as we had fled from my residence to save ourselves from the robbers.

We are currently unemployed and taking shelter
at our relative's place.
