Subject: FIR on Destructions of Khongsai Veng, Imphal East, H.No. 89
on 4th May, 2023 at 3:00pm by Valley base miscreant.

Sir,

I am to state that, on 4th May 2023, at around 3pm, our locality Khongsai Veng, Laiphom Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. **89** (Permanent Residence) was also destroyed by the mob, many properties were burnt and leftover looted.

property looted, burnt and destroyed includes:

3. Immovable properties like House having one storey pucca building

4. Movable properties

- a) Gold & jewelry : **1 Gold chain, 2 pairs of Earrings**
- b) Granary & Grain : **NIL**
- c) Vehicle: **Activa (MN02A8763)**
- d) Documents: **Misao Gas book**
- e) Furniture **4 Almirah, 2 Dinning Set, 1 Long Bench, 8 chairs, 3 Tables, 6 Beds**
- f) Traditional Ornaments **1 Khibas**
- g) Modern and traditional garments. **15 Shawls, 20 Wrap-Around**
- h) Electronic items. **Desktop, TV, 2 Refrigerator, washing machine**
- i) Cash **Rs. 1 lakh only**
- j) Kitchen Items: **3 Gas cylinder, 1 Gas stove, utensils , 3 Syntex, 1 Kitchen Almirah**

Total loss of properties at my residence would be above Rs. **20 lakhs**

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police station as I had fled from my residence to safe myself and my families from the rioters.
