

Subject: Report for burning down of the Tangkhul Baptist Church Building and Pastor Quarter, National Games Village, Lamphel, Imphal, Constructed under Patta No. 213 (Pt) Ang (Old)/Patta No. 505/4129 (New), C.S. Dag No. 23/1190 of No. 91-Meitei Langol, Imphal West District, Manipur.

Sir,

It is brought to your notice that, on 04-05-2023 at about 1:00 p.m, some unknown mob set fire and burnt down our Tangkhul Baptist Church Building and Pastor Quarter along with some properties located at National Games village, Lamphel Imphal West. As a result of the unfortunate incident the said properties were completely burnt down and turned into ash.

True copies of the photographs of the buildings before and after the incident are enclosed herewith and marked as Annexure A/1.

It is pertinent to mention that the church was constructed in a plot of land legally allotted and the Church is also in possession of valid Jamabandi issued by the State Revenue Department. The extensive damage has been assessed by competent engineers and the damage amount is ₹ 2,11,60,000/- (Rupees Two Crore Eleven Lakhs Sixty Thousand) only. The general abstract costs of the buildings construction are as follow:
