



Subject : Lodging of Zero FIR

Sir/Mam,

It is to inform you that on 4th May, 2023 at around 11:00 am, a group of unknown miscreants numbering more than 500 (five hundred) persons suspected to be of Meitei organization attacked, vandalized and looted my residence at Langol Housing Complex, Type-3, H-20, Imphal west in a broad daylight. The following household properties were stolen, vandalized and looted:-
1) Refrigerator- 2 stolen 2) Smart TV -2 Stolen 3) Washing machine - 2 stolen 4) Battery/Invertor-2 sets stolen 5) RO water purifier- 2 stolen 6) Mattresses - 5 stolen 7) Wooden bed- 5 stolen 8) Sofa - 4 sets stolen 9) Two wheeler - Activa Stolen 10) Xenon pick up truck - damaged/burnt beyond repairable 11) Almirah- 10 stolen 12) Dressing table - 2 stolen 13) Gas box-3 stolen 14) Dining table - 2 sets 15) Gas cylinder- 6 cylinder stolen 16) Blanket - 15 blankets stolen 17) Modern Carpentry Hi-tech tools and accessories like Jai Prima, bandshaw, planer, Jigsaw circular saw etc. worth around Rs. 13(Thirteen) lakhs were stolen.

The approximate total cost of the looted/ damaged properties is around Rs. 40,00,000 (Forty Lakhs) in value.

It is therefore, requested you to lodge an FIR in connection with the incident and take up necessary action against the culprits at the earliest.
