

Sir,

I am to state that on 4th May, 2023 at about 3:00PM locality Langol H/Complex under Lamphal Police Station (Imphal West) was under mob attacked by thousands of a Meitei organization led by (C.M N Biren Singh) i.e Arambai Tenggol, Kangleipak Kanbalup, MSF with an intend to Murder.

As a result, many houses and properties worth Rs. 80lakhs were destroyed and looted. Total loss of estimated properties looted would be above 80,00,000/- Eighty lakhs.

It is therefore kindly request to take necessary legal action to arrest the culprit involved in the incident at the earliest in the intrest of justice. I hereby lodged my complaint at Kangpokpi Police Station as I had fled from my resident to safe myself and my families from the rioters.
