Subject: Complaint report.

Sir,

I am to state that, on 4th May 2023 at about 3:00 pm, our locality Khongsai Veng, Laipham Khunou under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with criminal intention to cause damage of property and life. They were armed with deadly weapons including automatic rifles, SBBL, knives, etc.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. Among which my house No.76(permanent residence) was also destroyed by the mob, many properties were burnt and leftovers were looted.

Lists of properties (both immovable & movable) looted, burnt and destroyed are given below:

1. One Pucca house with 6 rooms, One Storey roofing house with 11 rooms along with Grocery Shop.
2. 4 Gold earring, Traditional ornaments-5 necklace (Khiba) and garments of Coat suit, shawl, wrap around (Ponve), etc.
3. 200 bags of grain and 50 bags of Rice
4. Vehicle- One 4Wheeler Maruti 800 B/R.No. MN01W-3530, Activa B/R.No. MN01F-6075 & Royal Enfield Classic 350 B/R.No. MN01AB-4955 and one gear Bi-cycle
5. Furniture includes Dining table set, 4 Kingsize beds, 6 Almirah, 2 bed box, Sofa set-03 & Three dressing table, 2 Steel Godrej Almirah and Kitchen Showbox.
6. 5-cylinder gas, gas stove and one Misao Gas connection.
7. 75" Tv & 35" TV, Refrigerator-02 nos, Washing Machine-2nos, 3 laptop & 2 Desktop with printer, RO, Oven, Dispenser, Kitchen Chimney, Geysur-02 nos, Nescafe vending machine, Ice-cream freezer, Freezer-02 nos, Shop Almirah-03nos.
9. Misc- Blanket & clothing of 7 family members, Plastic chair-10, books, syntex, kitchen utensils and Water pump Tulu
10. Cash-3.5 lacs

The approximate total loss of properties would be Rs 10 crores.

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
