Subject: Complaint report.

Sir,

I am to state that, on 4th May 2023 at about 3: 00 pm, our locality Khongsai Veng, Laipham Khunou under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with criminal intention to cause damage of property and life. They were armed with deadly weapons including automatic rifles, SBBL, knives, etc.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. Among which my house No. 73 (permanent residence) was also destroyed by the mob, many properties were burnt and leftovers were looted.

Lists of properties (both immovable & movable) looted, burnt and destroyed are given below:

1. Pucca house with 6 rooms (45x45 ft), Plot size-65x80
2. 2 Gold earring, Traditional ornaments-3 necklace (Khiba) and garments of Coat suit, shawl, wrap around (Ponve), etc.
3. 100 bags of grain
4. Vehicle- One Scorpio B/R.No. ML-05G-2910
5. Dining table set, 4 Kingsize beds and 6 Almirah and two bed box, Sofa set-03-& Four dressing table, 2 Steel Godrej Almirah, Bookshelf.
6. 6-cylinder gas and gas stove.
7. 75" Tv, Refrigerator, Washing Machine-2, 3 laptop & 2 Desktop, RO, Oven, Dispenser, heater, chimney.
8. Building construction materials.
9. Misc- Bed mattresses-4 Nos, all Blanket & clothes, Plastic chair-10, books, syntax and kitchen utensils.

The approximate total loss of properties would be Rs 5 crores.

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to safe myself and my families from the rioters.
