Sir,

I am to state that on 4th May 2023, at about 3 p.m. our locality Khongsai Veng, Laipham Khunou under Lamphel police station (1/w) was under mob attack by thousands of unknown miscreants belonging to the Meitei community with an intent to murder.

As a result, many houses and properties worth crores of rupees were destroyed and burnt to ashes. My house NO. 118(A)-Rented was also destroyed by the mob and left over looted. Total loss of properties at my residence would be above one (1) crore.

It is therefore, requested to take necessary legal action to arrest the culprits involve in the incident at the earliest in the interest of justice. I hereby lodge my complaint at Kangpokpi as I have fled from my residence for the safety of myself and my daughter.
