Sir,

I am to state that on 4th May, 2023, at around 8 PM, our locality Khongsai Veng, Laipham Khumou, under Lamphel Police Station (I/W) was under mob attacked by thousands of untouchable miscreants belonging to the Meitei community with an intent to murder.

As a result, many houses and properties worth crores of rupees were destroyed and burnt to ashes. My house No. 118(A) was also destroyed by the mob, many properties were burnt and leftovers looted. Total loss of properties at my residence would be above three (2) crores.

It is therefore, requested to take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at Kangpokpi Police Station as I have fled from my residence for the safety of myself and my family members.
