Sir,

I am to state that on May 4<sup>th</sup> 2023, at around 3pm our locality Khongsai veng Laiphamkhunou, under Lamphel Police station (Imphal west and falling under revenue of Imphalea was under mob attacked by thousand of unknown miscreant belonging to the Meities community with an intend to murder

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house no. 7(a) Rented was also destroyed by the mob, many properties looted, burnt and destroyed include Gold Jewelry, grain, Document, vehicle. MN06SC 8848 Royal emfield None Henmunlen Khongsai and ACTIVA 1 MN06SC 5104 in the name of Lungpineng Lipheng, furniture Traditional ornament, Gas cylinder, electronic item cash of ₹ 40,000. Total loss properties at my residence would be above .80 lakh.

It is therefore kindly requested to takes necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complaint at Kangpokpi Police station as I had fled from my residence to safe myself and my families from the rioters.

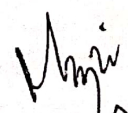
