Sir,

I am to state that on 4th May 2023, at around 3pm our locality Khongsai Veng Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousand of unknown men belonging to the Meitei Community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes, my house no. 6 (b) Rented was also destroyed by the mob, many properties looted, burnt and destroyed include gold jewelry, grain, Document, vehicles, furniture, Tractor, lional ornament, Gas cylinder, electronic items, Cash of, ₹ 2,55,000. Loss properties at my residence would be above ₹ 80. lakh.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complaint at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
