Dear Sir,

I, the undersigned beg to state that some unknown gun toting Kuki Militants have looted and taken away all my properties kept inside my house at **Moreh Ward No. 8, Tengnoupal District, Manipur around 9.30 am on 28th May, 2023 on the day of Sunday** and thereafter have burnt it down. However I could not file the complaint earlier as I have fled fearing for my life and hence here is delay in filing this complaint. I am presently staying at Lamboikhongnangkhang, Imphal West District.

I request you to kindly take up necessary legal action against the culprits and restore my properties whatever may be recovered.

And for this act of kindness, I shall remain ever grateful to you. I am herewith enclosing details of my properties destroyed and looted by the said Kuki Militants.
