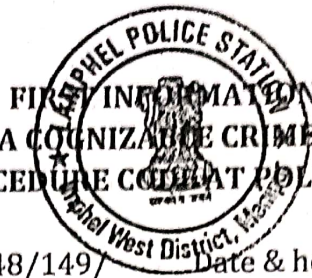

Today i.e., 1<sup>st</sup> June, 2023 at 11:45 pm, received information that on the same day at about 11:30 pm one unknown person who was suspected to be belonged to Kuki Community was detained and assaulted by some unknown persons at the entrance road of Lei-Ingkhol, Chingmeirong, Imphal East following the current crisis/riot. Upon receiving the reliable information, a team of Lamphel Police Station rushed to the said area and rescued the severely injured unknown person meanwhile Lamphel Police Vehicle 407 Tata bearing registration No. NIL was attacked by mob and the vehicle got partly damage on its front wind shield. The Police team also dispersed the unruly mob and the severely injured person was evacuated to RIMS Hospital, Lamphel for medical treatment.

Hence, a Suo-Moto case under FIR. No. 508(6)2023 LPS u/s 147/148/149/326/353/427-IPC has been registered for investigation.
