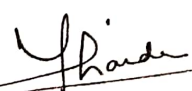

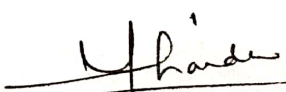

Respected Sir,

Most respectfully, I beg to state that the Lamphei Quarter No. 7/1/6(1B) in the Name of Kham Suammung Taumbing was robbed by unknown persons.

This matter happens during the ethnic clash and recent violence in Manipur. On 4th of May 2023 K.S. Taumbing left the Quarter on Morning and went to CRPF relief camp, that time he called me up to handover his Quarter Keys and asked me to look over his Quarter. On 28th May 2023, when he called me up to go and checked his Quarter, I found out that some unknown persons break in and robbed several items which include 1(one) sinker of 2000 liters, 1(one) water pump of 1HP, several number of water taps, wash basin, LED bulbs, furniture items, clothes, A.C. etc. So, in between 3rd to 28th of May, 2023 unknown persons have break in and robbed from the Quarter.

So, in behalf of K.S. Taumbing, I myself have write this F.I.R complaint Report against property Robbed. Therefore, I am requesting you to kindly file up F.I.R. and look into necessary action.
