I am to state that on 4th May 2023, at around 3pm, our locality Khongsai veng Laipham Khunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousand of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and Properties worth crores were destroyed and burnt to ashes, my house no 6(a) Rented was also destroyed by the mob, many properties, looted, burnt and destroyed include Gold Jewelry, grain Document, Vehicles Activa no MNDIR 8827, furniture, Traditional ornament, Gas cylinder, electronic items, cash ₹ 30,000/- Total loss properties at my residence would be above ₹ 75 lakh.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
