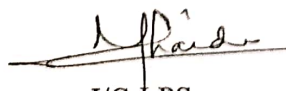

Sir,

I am to state that on 4th May 2023, at around 3pm, our locality Khongsai Veng, Laiph Khunnu, under Lamphel Police Station (1/14) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores of rupees were destroyed and burnt to ashes. My house No. 118 (B) was also destroyed by the mobs, many properties were burnt and leftovers looted. Total loss of properties at my residence would be above Two (2) crores.

It is therefore, requested to take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at Kangpokpi Police Station as I have fled from my residence for the safety of myself and my family members.
