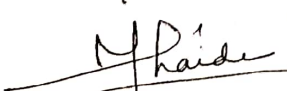

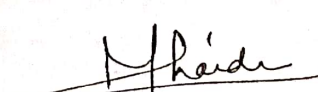

Sir,

I am to state that on 4th May 2023, at around 3 P.M., our locality Khongsai Veng, Laiphram Khunou, under Lamphel Police Station (I/W) was under mob attack by thousands of unknown miscreants belonging to the Meitei community with an attempt to murder.

As a result, many houses and properties worth crores of rupees were destroyed. My house NO. 118 (C) was burnt to ashes. By the mob, many properties were burnt and leftovers looted. Total loss of properties at my residence would be above one (1) crore.

It is therefore, requested to take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at Kangpokpi Police Station as I have fled from my residence for the safety of myself and my family members.
