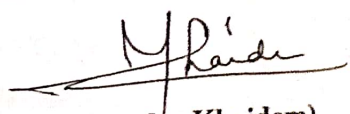

Sub: Complaint report

Sir

I am to state that, on 4th May 2023, at around 3pm our locality Khongsai veng Laphamkhunou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attack by thousand of unknown miscreants belong to the so called Meiteis Community with an intend to Murder.

As a result, many houses and properties worth crores was destroyed and burnt to ashes. My house no 6 permanent residence. was also destroyed by mob, many properties were burnt and leftover looted. Properties looted burnt and destroyed included immovable properties, movable properties Jewellery, Gramary and grain, Document, gas cylinder, electronic items and cash of 80,000/- Total loss of properties at my residence would be above 3 crores.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
