I am to state that, on 4<sup>th</sup> May 2023, at around 3pm our locality Khongsai Veng Laiphamkhenou, under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) was under mob attack by thousand of unknown miscreants belong to the Meitei Community with an intend to murder.

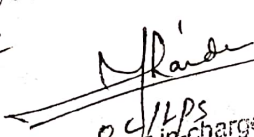
As a result, many houses and properties worth crores was destroyed and burnt to ashes my house number 7(A) permanent residence was also destroyed by mob, many properties were burnt leftover looted properties looted, burnt and destroyed included Jewellery, vehicles no ASOIEB 8414 Royal Enfield Thunderbird in the name of Mangmunlin Baite furniture, Traditional ornament gas cylinders, electronic items and cash of Rs. 70,000/- Total loss of properties at my residence would be above 75 Lakh.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.

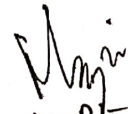
