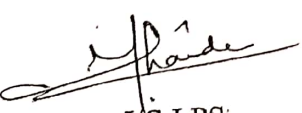

Sir

I am to state that, on 4th May 2023, at around 3pm our locality Khongsai Veng Laipham Khunou, under Lamphel police station (Imphal west and falling under revenue of Imphal East) was under mob attacked by thousand of unknown miscreants belong to the Meities community with an intend to murder.

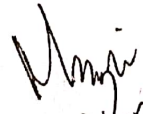
As a result, many houses and properties worth crores was destroyed and burnt to ashes. My house number 7 permanent residence was also destroyed by mob, many properties were burnt leftover looted. Properties looted, burnt and destroyed included movable properties, Jewelry, Granary and grain Document, Vehicles no. MN03A-3858 ALTO LXI SILVER in the name of Hethang Khongsai, furniture, Traditional ornament gas cylinder, electronic items and cash of Rs. 30 lakh. Total loss of properties at my residence would be above 2 crores.

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of Justice. I hereby lodged my complain at Kangpokpi Police Station as I fled from my residence to save myself and my families from the rioters.
