I have the honour to state that, on 4th May, 2023 at around 11:30 AM some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Arambai Tenggol who are loyal group to the present Inner MP, Shri Leishemba Sanajaoba, World Meitei Council (WMC), Meetei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC), Manipur Police And Commandos numbering about 1000+ members carrying sophisticated weapons like AK rifles, 303 Rifles, SBBL, Pistol, Molotov, etc. with vehicles forcefully entered in my village and looted my church located at Langol Housing Complex and took away the following items listed below:

- 1) PA System inclusive of Mixer, 4 Nos of FM Microphone and 3 Nos of Speaker.
- 2) 50 Nos of blankets washed by Youth department for their fund raising.

I therefore, requested to kindly registered a regular case and take necessary legal action according to law.
